TAX REFORM CHANGES

The 2018 Tax Reform law permits a depreciation allowance of 100% for qualified new and used property acquired and placed into service, allowable in the first year. Customers can act now and purchase a new Volvo truck to take advantage of this benefit. For some customers, this could potentially increase tax loss carry-forwards*.

Eligible customers may also be able to take advantage of the Section 179 Deduction, which allows qualifying businesses a deduction on the first \$1,000,000 of new or used equipment they purchase that is placed into service on or after January 1, 2018*.



Other Tax Reform Changes:

- Corporate Tax Rate changes from 35% to 21%
- S-Corp. pass-through Tax Rate changes from 39.6% to 25%
